SID Statistics

SID has been moved to Rushmore Lane and, from 2nd June 2020 until 15th June 2020, clocked 1,461 vehicles exceeding the speed limit, giving a daily average of 140 vehicles speeding. Considering the country is still on partial lockdown this is a very worrying figure for a country road. The reply from the Safer Roads Partnership regarding the update from the West Mercia Road Safety Team Forum agenda item was that they understood that *Wrockwardine Wood Parish Council was in discussion with Telford & Wrekin Council over a planned scheme...* It has since been confirmed that they did indeed mean Wrockwardine Parish Council. The Chairman requested a further reply to ask whether the confusion was hampering their involvement and advising that the discussions with Telford & Wrekin had failed to reach an agreed scheme of works. The question was asked again how they could help and support in finding a solution to the extremely dangerous situation on the Parish roads.

Virtual Meetings Update

The Wrekin Area Committee meeting was held on Wednesday $17^{\rm th}$ June 2020 where local issues were discussed. The minutes are attached with this update for information.

The Clerk attended the SLCC Shropshire Branch Clerk's catch up where the current situation was discussed, problems and good news stories shared alongside a look at future working as restrictions are lifted.

The Haygate Fields Stakeholder Group met today (Friday 26th June) via Microsoft Teams where site developments and issues were discussed.

And finally, the Allscott Meads Stakeholder Group is scheduled to meet via Microsoft Teams on Thursday July 2^{nd} . The Clerk will represent the Parish Council in the absence of the Chairman.

No Parish Council Meeting in July

Following a discussion with the Chairman and Vice-Chairman it has been agreed not to call a meeting in July.

However, discussions are taking place regarding the holding of a virtual meeting in August or, if guidance allows it, a physical meeting of the Council adhering to social distancing rules and perhaps with the possibility of it being held outdoors. The public would of course be notified in the normal way and invited to attend.

This would enable the AGAR to be signed off and sent to the external auditors and for the Council to publish the dates of the period for the public inspection of the AGAR and accounts, the notification of which has to start no later than 1st September 2020.
